## REPORTS:

Cars should be parked off-site during that time. Sealtech will provide fliers for our residents with the pertinent information. Carol Burton from DCM will call Sealtech and ask them to do a walk-through with Carolyn and Jim prior to those dates so they can see and evaluate the deteriorating areas before they come to actually do the work on 5/29 and 5/30.

Our entry sign has been effectively illuminated with a solar power light plus we now have a clubhouse sign attached to the building---all courtesy of Jim Williams. There was a brief discussion about the possible need of a second clubhouse sign at street level; no action needed on this idea just yet.

LANDSCAPING: The new fencing bids were perused/discussed and it was decided Precise Fencing will be the company who will do our fence repair along

27<sup>th</sup> St. The tree root problem at building 7 was discussed, the tree and all the roots have been removed. In a month or so Karen Renaud-Williams and Susan Fish will go tree shopping and find a more suitable replacement for the common area in the front. Carol Burton informed us new Beauty Bark mulch will cost approximately \$350-\$375 for the yardage needed plus there will be a fee for delivery.
